CATALOG DESCRIPTION: An overview of the materials and services for children and young adults in a public library with emphasis on the role of the LTA. Emphasis is placed on developing a working knowledge of programming for youth ages 0-18. This course will also provide an overview of children's literature, both classic and contemporary, and reference resources that will assist the LTA in providing reader's advisory to youth.

MAJOR COURSE LEARNING OBJECTIVES: Upon successful completion of this course the student will be expected to:

1. Identify philosophies of library services to children.
2. Describe the physical environment children's department in a public library including display areas, staff areas, and programming areas.
3. Design story time programs for children ages birth to 9.
4. Create programs for pre-teens and teens.
5. Plan programs for families and multi-age groups.
6. Identify resources to assist with reader's advisory and reference to children and teens.
7. Prepare a thematic display for a children's department.
8. Recognize award winning children's and teen literature.
9. Examine the laws relating to copyright, intellectual freedom, censorship, and privacy as they relate to children's services.
10. Identify the issues and trends in library services to children.
11. Compose a personal philosophy of library service to children.
